Competition Rules and Regulations

RULES FOR KATA

1- Head official/ 2- Corner officials/ 1-Time keeper/ 1-Score Keeper

First round- Kata elimination

2 participants Flag System

Second round to finals

Point system – Each referee will award a score. Base number being $\underline{7.0}$ Lowest score due to disqualification would be $\underline{6.4}$ A perfect score would receive a 7.6

RULES FOR KUMITE

1 Head Official/ 2 or 4 corner officials/ 1 Score Keeper/ 1 Time Keeper

Each match is **3 minutes** continues running time monitored by **Chief referee** stopping time with **timekeeper** and communicating point allotment with **scorekeeper**.

Ippon Shobu 1 point match)- The competitor who has scored one full point or 2 half points first, within the allotted time is declared the winner.

Final matches will be Sanbon Shobu (Youth/Adult)- The competitor who has scored 2 full points first, with the allotted time, is the declared winner.

Target Areas:

Head, chest and stomach, back If participant is foot swept or thrown to receive a point it must be followed up by a strike of foot or hand What is considered a fair point

For a participant to receive a point his intent must have maximum spirit and to focus to area which his hand or foot is visually seen **touching** opponent by one of two referees.

Excessive contact will not be tolerated.

First time warning, second time point awarded to other side.

If dangerous technique is executed with intention to hurt opponent or excessive contact were blood is drawn, individuals will be disqualified from the match

Other Match Discrepancies

Out of bounds – first time warning, second time warning, third time point awarded to other side.

If match has not been decided in the allotted 3 minutes or if there is a tie there will be a two minutes overtime match to 3 points.

If match is still not decided then Head official will make decision on winner based on spirit, aggressiveness, out of bounds etcetera.

RULES FOR KIHON IPPON KUMITE

Kihon Ippon Kumite consists of both participants doing 3 attacks from one side announcing before their attack Jodan, Chudan, Mae-geri. Person defending will block and counter with a punch after. Only the right side for attacking, and if it's a draw they will reset and do their left side after the flags have indicated a draw.

Brown and Black belt divisions: Jiyu Ippon Kumite (Semi free sparring) Jodan, Chudan, Mae-geri. Only right side, and if a draw will reset and do left side.

*All competitors must wear proper protective equipment to compete in Kumite which includes a mouth guard, JKA approved fist protectors, groin protector are mandatory. Extra protective gear is optional.

• RULES FOR FAMILY TEAM KATA

Family Team Kata consists of 3 members regardless of gender for junior divisions up to the age of 14 years old. Team members can vary in belt rank but should consist of similar ages within a 2 years variance between team members. If unclear please speak with Tournament Director – Sensei Paul Atkin before the competition.
